#### REQUIREMENTS WHILE HOLDING INITIAL CERTIFICATION

- If the Initial certificate was issued on the basis of an out-of-state certificate, the certificate holder must submit official passing scores on an approved basic competency exam to the Teacher Certification office by the expiration date on this certificate.
- 2. If the Initial certificate was issued on the basis of program enrollment, the certificate holder must either:
  - request the second and final year to complete the teacher preparation program by submitting an updated program enrollment form and an original transcripts showing progress in their program by the expiration date on this certificate, or
  - submit an institutional recommendation and official transcripts showing completion of the teacher preparation program by the expiration date on this certificate.
- If the requirements described above are satisfied, the certificate holder, with the exception of an Initial Reemployment Certificate, must submit official transcripts within two years of the valid date of the certificate showing the completion of:
  - a. three (3) semester hours of approved Alaska Studies coursework, and
  - three (3) semester hours of approved Multicultural/Cross-cultural Communications coursework.

If the requirements described above are satisfied, an Initial certificate, with the exception of an Initial Reemployment certificate, can be valid for up to three years.

#### SPECIAL NOTE FOR INITIAL REEMPLOYMENT CERTIFICATE

An Initial Reemployment certificate can only be valid for one year. Teachers holding an Initial Reemployment must satisfy all requirements for Professional certification.

#### PROFESSIONAL CERTIFICATION REQUIREMENTS

- 1. Eligible for an Alaska Initial certificate.
- 2. Two (2) years of teaching experience.
- 3. Passing scores on an approved basic competency exam (i.e. Praxis Core Academic Skills for Educators)
- 4. An institutional or state recommendation.
- 5. Official transcripts showing completion of:
  - a. an approved teacher preparation program,
  - six (6) semester hours of recency credit earned at a regionally accredited university in the five (5) years prior to Professional application,
  - c. three (3) semester hours of approved Alaska Studies coursework, and
  - three (3) semester hours of approved Multicultural/Cross-cultural Communications coursework.
- Passing scores on an approved content area exam. (i.e. Praxis II)
- 7. A fingerprint card or employment verification.
- 8. Professional certification application.
